

Centsible Moms Consignments, LLC Consignor and/or Volunteer Agreement

This agreement is between Centsible Moms Consignments, LLC and _____, Referred to hereafter as Consignor or Volunteer.

1) The consignor agrees to allow Centsible Moms Consignments, LLC to sell on behalf of the consignor any or all items brought to the sale that is accepted. The consignor acknowledges that Centsible Moms Consignments, LLC and its appointed representatives will have the final say as to an item's appropriateness. The consignor assumes responsibility as the reseller of the items. Centsible Moms Consignments, LLC is not the reseller, but rather the facilitator of the arrangements for the event. Qualifications for items can be found prior to the sale at www.centsiblemoms.net.

2) The consignor agrees that they will appropriately tag and prepare all items as directed at www.centsiblemoms.net. The consignor agrees that they are completely responsible for proper tagging ensuring that it is securely attached to each item. Consignor agrees that any item found without a tag cannot be sold and will be placed in a lost and found area to be claimed by the consignor. The consignor agrees that any items left in the lost and found at the close of the pick-up time will become the property of Centsible Moms Consignments, LLC.

3) The consignor will indemnify and hold Centsible Moms Consignments, LLC completely harmless in the Event of loss or errors on the tags.

4) The consignor will indemnify and Centsible Moms Consignments, LLC completely harmless and the Consignor will be responsible for any personal injury or damages resulting from any item or sold items.

5) The consignor agrees that Centsible Moms Consignments, LLC will take all reasonable steps to ensure the security of the consignor's items. However, the consignor will not hold Centsible Moms Consignments, LLC responsible for missing items due to, but not limited to, theft, mysterious disappearance, loss of items, fire, damage, or other "Acts of God". The consignor assumes the risks of these events occurring by participating in the sale.

6) The consignor acknowledges full responsibility to ensure that all items accepted by Centsible Moms Consignments, LLC have not been recalled, and the items are in safe working order and have no broken or missing parts. Additionally, should the consignor sell or donate an item that exceeds new Government standards of lead levels, the consignor will be responsible for any and all costs, fines, or legal fees as a result of a sale or donation in violation of government standards.

7) The consignor agrees that all items will be sold at 50% off on the ½ Price Sale day unless the tag is clearly indicated with "NO". The consignor additionally agrees that any items not claimed during the specified sorting and pick-up time will become the property of Centsible Moms Consignments, LLC.

8) The consignor agrees that he/she will make no claims against Centsible Moms Consignments, LLC or any of its representatives for any discrepancies of items. Additionally, the consignor waives the right for any and all claims, including personal injury and/or physical damages, against Centsible Moms Consignments, LLC any of its representatives, and the leasers of the space, that are in anyway related to the sale.

9) Centsible Moms Consignments, LLC acknowledges responsibility to mail the consignor's portion of the proceeds no later than 14 days following the close of the sale. The basic consignor commission is 70%. The consignor also agrees to have a registration fee of \$10 deducted from their proceeds.

10) Consignors who desire to earn early shopping privileges may agree to work a volunteer shift. Consignors agree that if they are unable to work their chosen volunteer shift they will provide Centsible Moms Consignments, LLC a minimum 5 days notice of the need to cancel their shift. Consignor/Volunteer agrees that if they do not show up to work their volunteer shift without prior notice they will be placed on a “no show” list preventing them from being able to volunteer at any future sale.
